

Prime Contractor Monthly Prompt Payment Certification Form

Purpose

This certification form is used to monitor prime contractor compliance with the prompt payment terms contained in IndyGo's Disadvantaged Business Enterprise (DBE) Program, the prime's contract, and US Department of Transportation regulations. IndyGo's DBE Program states prime contractors must pay their subcontractors for satisfactory performance of their contracts no later than fifteen (15) days from the prime contractor's receipt of payment from IndyGo.

Please type information into the fields below and return this form to <u>supplierdiversity@indygo.net</u> by the 10th of each month. All contractors are required to complete and return this form each month for each active project until receiving final payment. Include all payments made to <u>all</u> subcontractors on each active project. Record "no payment" if you did not make a payment to the subcontractor for this reporting period. Use the notes field to report any delayed payments and attach supporting documentation or a written justification. Attach additional sheets if necessary.

Failure to complete this reporting requirement may result in withholding of the prime contractor's next progress payment or the final payment, issuing a corrective action plan, and/or cancellation or suspension of the contract in whole or in part.
